**AN ORDINANCE AMENDING ORDINANCE NO. 17, SERIES OF 2022, ENTITLED: "AN ORDINANCE CREATING THE PROVINCIAL YOUTH DEVELOPMENT OFFICE (PYDO), ELEVATING THE SAME AS A SEPARATE DEPARTMENT OF THE PROVINCIAL GOVERNMENT OF NORTHERN SAMAR, RETITLING AND SUBSEQUENTLY ABOLISHING/DISSOLVING THE FOLLOWING ITEMS: SPECIAL OPERATION OFFICER IV, SG-22 (ITEM NO. PGO 22); SECURITY GUARD I, SG-3 (ITEM NO. PGO 35-8); AGRICULTURAL TECHNICIAN I (SG-6 (ITEM NO. PAO 150-20); ADMINISTRATIVE AIDE IV (CLERK II), SG-4 (ITEM NO. PAO 8-64); ADMINISTRATIVE AIDE III (CLERK I), SG-3 (ITEM NO. PCCAO 10-53); AND LAUNDRY WORKER I, SG-1 (ITEM NO. BDH 120-7) AND UTILIZING THEIR RESPECTIVE PERSONAL SERVICES COST TO COVER THE SALARIES, OTHER COMPENSATION, AND BENEFITS ATTACHED TO THE ITEMS UNDER THE SAID NEWLY CREATED DEPARTMENT AS FOLLOWS: PROVINCIAL GOVERNMENT ASSISTANT DEPARTMENT HEAD, SG-24 (ITEM NO. PYDO 54-16); YOUTH DEVELOPMENT OFFICER I, SG-11 (ITEM NO. PYDO 64-5); AND YOUTH DEVELOPMENT OFFICER I, SG-11 (ITEM NO. PYDO 64-6)", PARTICULARLY SECTION 3 THEREOF**

Section 1. Section 3 of Ordinance No. 17, Series of 2022, entitled: "An Ordinance creating the Provincial Youth Development Office (PYDO), elevating the same as a separate department of the Provincial Government of Northern Samar, retitling and subsequently abolishing/dissolving the following items: Special Operation Officer IV, SG-22 (Item No. PGO 22); Security Guard I, SG-3 (Item No. PGO 35-8); Agricultural Technician I (SG-6 (Item No. PAO 150-20); Administrative Aide IV (Clerk II), SG-4 (Item No. PAO 8-64); Administrative Aide III (Clerk I), SG-3 (Item No. PCCAO 10-53); and Laundry Worker I, SG-1 (Item No. BDH 120-7) and utilizing their respective personal services cost to cover the Salaries, Other Compensation, and Benefits attached to the items under the said newly created Department as follows: Provincial Government Assistant Department Head, SG-24
